In re: AMANDA WARDLE

CONSENT AGREEMENT

IT IS HEARBY AGREED by the South Dakota Board of Medical and Osteopathic Examiners (Board) and Amanda Wardle (Ms. Wardle) as follows:

1. Registration status: Ms. Wardle does not presently hold a registration to practice as a medical assistant in South Dakota.
2. Admission/Facts: Ms. Wardle admits to the following facts:
 - a. That Ms. Wardle desires to obtain a medical assistant registration and has submitted a medical assistant registration Application.
 - b. That Ms. Wardle was required by statute to obtain registration prior to working as a medical assistant.
 - c. That Ms. Wardle represented herself as a medical assistant and performed the duties of a medical assistant prior to being registered.
3. Informal Agreement: It is the intent of the parties of this Consent Agreement with Reprimand to provide for the informal compromise and settlement of all issues which could be raised by a formal contested hearing.
4. Waiver of Rights: Ms. Wardle understands she has the right to consult with an attorney who is licensed in South Dakota, and if no attorney signs this agreement, she waives said right. She also has a right to an administrative hearing on the facts in this case. Ms. Wardle understands and agrees that by signing this Consent Agreement with Reprimand, she is waiving her rights to a hearing. Ms. Wardle further understands and agrees that by signing this Consent Agreement with Reprimand, she is voluntarily and knowingly giving up her right to present oral and documentary evidence, to present rebuttal evidence, to cross-examine witnesses against Ms. Wardle, and to appeal the Board's decision to Circuit Court.
5. Consent Agreement, Decision and Order: Ms. Wardle agrees that the Board has the authority to enter into this Consent Agreement and to issue the following Decision and subsequent Order.

REPRIMAND


The registration, if issued to Ms. Wardle, shall be subject to the following terms and conditions:

- B. Reprimand: The following reprimand shall be placed in Ms. Wardle's file with this Consent Agreement:

The Board hereby reprimands you, Amanda Wardle for practicing as a medical assistant in South Dakota without a current and valid registration. The Board considers practicing as a medical assistant without a registration a serious matter.

IT IS HEARBY FURTHER AGREED that this Consent Agreement with Reprimand shall take effect immediately and is a public record of the Board and the State of South Dakota. The Board may provide a copy of it to any person or entity; professional licensing board; federal, state; or local government; or other entity making a legal inquiry. The action taken by the Board in this Consent Agreement will be published on the Board's web site, to the Federation of State Medical Boards and the National Practitioner Data Bank, and any other entity deemed appropriate by the Board.

WHEREAS, Ms. Wardle has unconditionally accepted this Consent Agreement with Reprimand by affixing her signature to this document.

REPRIMAND


