WHEREAS, Anastasios Pappas, M.D., is the holder of license #4426 of the South Dakota Board of Medical and Osteopathic Examiners, hereinafter referred to as Board, and

WHEREAS, the South Dakota Board of Medical and Osteopathic Examiners has jurisdiction of the parties and subject matter herein, and

WHEREAS, the Board is in receipt of certain information which evidences that Anastasios Pappas, M.D., entered into a plea agreement in a criminal case prosecuted by the Office of the United States Attorney for the District of South Dakota regarding his practice of introducing misbranded TRI-Toxin into interstate commerce in violation of federal law. This constitutes unprofessional conduct on the part of Anastasios Pappas, M.D., and constitutes grounds for

cancellation, revocation, suspension or limitation of his South Dakota license to practice medicine, and

WHEREAS, Anastasios Pappas, M.D., pursuant to the plea bargain agreement on April 4, 2006, agreed to surrender his medical license; and

WHEREAS, the Board has accepted the voluntary surrender of license #4426 issued to Anastasios Pappas, M.D., due to his plea agreement as referenced above;

THEREFORE, IT IS HEREBY ORDERED pursuant to the request of Anastasios Pappas, M.D., and the Board's finding that Anastasios Pappas, M.D., has entered into a plea agreement in a criminal matter with the United States Attorney for the District of South Dakota, and that the Board accepts the VOLUNTARY SURRENDER of license #4426 issued to Anastasios Pappas, M.D.
