WHEREAS, Kristene M. Rancour is the holder of an Emergency Medical Technician Paramedic license, issued by the South Dakota Board of Medical and Osteopathic Examiners, hereinafter referred to as the Board, and

WHEREAS, the Board has jurisdiction of the parties and subject matter herein, and

WHEREAS, on December 4, 2007, Ms. Rancour signed a Stipulation and Order of Reprimand due to her abuse of alcohol, and she has participated in South Dakota Health Professionals Assistance Program (SD HPAP) and has maintained her sobriety, and

WHEREAS, Ms. Rancour understands that the Board has discretion to approve this Addendum to the Stipulation and Order of Reprimand , and

WHEREAS, Ms. Rancour failed on at least four occasions to place the daily mandatory phone call to the Affinity On-line Services as required by South Dakota Health Professionals Assistance Program for the purpose of monitoring her abstinence from alcohol and/or controlled substances, and the Board views this failure as non-compliance, and

WHEREAS, Ms. Rancour agrees that she will execute her daily required calls to the Affinity On-line Services, and she further agrees that if she does not make her daily call, she will notify the Board office of the missed call on the day she missed the call, and

WHEREAS, Ms. Rancour agrees that failure to call the Affinity On-line Services on a daily basis and failure to report a missed call to the Board office may constitute grounds for the immediate suspension of her license.

WHEREAS, Ms. Rancour understands that the conditions of the December 4, 2007, Stipulation and Order of Reprimand are still in force and she understands and agrees to continue to comply with the conditions above, and she also agrees that she understands that this ADDENDUM TO STIPULATION AND LETTER OF REPRIMAND is a matter of public record that will be reported to all agencies as deemed necessary by the Board, and will be posted on the Board's Disciplinary Website for 2009. Furthermore, she understands that she has the right to an attorney, but waives the right if no attorney signs

this agreement. In addition, she waives her rights to due process of law if this agreement is approved by the Board.
