CONSENT AGREEMENT
WITH
In re: LUTHER HEGLAND, MD REPRIMAND

CONSENT AGREEMENT

IT IS HEARBY AGREED by the South Dakota Board of Medical and Osteopathic Examiners (Board) and Luther Hegland, MD (Dr. Hegland) as follows:

1. Licensure status: Dr. Hegland does not presently hold a license to practice medicine in South Dakota because he allowed his license to be forfeited for non-renewal. SDCL 36-4-24.2.
2. Admission/Jurisdiction: Dr. Hegland admits and agrees that the Board has jurisdiction over the subject matter of the reinstatement and renewal of his South Dakota medical license, and over this Consent Agreement with Reprimand.
3. Admission/Facts: Dr. Hegland admits to the following facts:
 - a. That Dr. Hegland was initially licensed by the Board on August 5, 2002.
 - b. That Dr. Hegland was required by statutes in the Medical Practices Act to renew his medical license on or before March 1, 2010.
 - c. That the Board sent all licensees courtesy renewal notifications by U.S. mail and email months before the March 1 deadline.
 - d. That Dr. Hegland failed to renew his medical license by the March 1, 2010 deadline and therefore his medical license was forfeited under the provisions of SDCL 36-4-24.2 for non-renewal.
 - e. That Dr. Hegland practiced medicine in South Dakota without a valid medical license on March 2, 2010.
 - f. That Dr. Hegland desires to apply for reinstatement and renewal of his license and has submitted a Reinstatement and Renewal Application.

4. Informal Agreement: It is the intent of the parties to this Consent Agreement with Reprimand to provide for the informal compromise and settlement of all issues which could be raised by a formal contested hearing.
5. Waiver of Rights: Dr. Hegland understands he has the right to consult with an attorney who is licensed in South Dakota, and if no attorney is present or signs this agreement, he waives said right. He also has a right to an administrative hearing on the facts in this case. Dr. Hegland understands and agrees that by signing this Consent Agreement, he is waiving his rights to a hearing. Dr. Hegland further understands and agrees that by signing this Consent Agreement with Reprimand he is voluntarily and knowingly giving up his right to present oral and documentary evidence, to present rebuttal evidence, to cross-examine witnesses against Dr. Hegland, and to appeal the Board's decision to Circuit Court.
6. Consent Agreement, Decision and Order: Dr. Hegland agrees that the Board has the authority to enter into this Consent Agreement and to issue the following Decision and subsequent Order.

FINE AND REPRIMAND

The license, if renewed and reinstated to Dr. Hegland, shall be subject to the following terms and conditions:


- A. Fine: Dr. Hegland shall pay a fine of \$200.00 prior to his medical license being reinstated and renewed.
- B. Reprimand: The following reprimand shall be placed in Dr. Hegland's file with this Consent Agreement:

The Board hereby reprimands you, Luther Hegland, MD for practicing medicine in South Dakota without a current and valid medical license. The issuance of a license to practice medicine in South Dakota is a privilege that is based, in part, upon timely renewals of your medical license. The Board considers practicing medicine without a license a serious matter.

IT IS HEREBY FURTHER AGREED that this Consent Agreement with fine and reprimand shall take effect immediately and is a public record of the Board and the State of South Dakota. The State may provide a copy of it to any person or entity, professional licensing board, federal, state, or local government, or other entity making a relevant inquiry. The action taken by the Board in this Consent Agreement will be published on the Board's web site, to the Federation

of State Medical Boards and the National Practitioner Data Bank, and any other entity deemed appropriate by the Board.


WHEREAS, Dr. Hegland has unconditionally accepted this Consent Agreement with Reprimand by affixing his signature to this document.

REPRIMAND


